Components

Hog casing or sheep casing

Brine (water, salt)

The natural casings listed in this document:

- Shall be free of filth, infestation and foreign matter and confirm to Food Standards Australia New Zealand (FSANZ) including identity and purity of the individual components as food grade additives and ingredients (e.g. salt) and shall comply with the New Zealand Food regulations when used according to instructions.
- Are cleaned and processed under good manufacturing conditions in export registered establishments.
- Are either dry salted or cured in salt or saturated brine for a minimum of 30 days.
